TOURISM SERVICES SECTION COMMITTEE COMPOSITION

The Tourism Services Section Committee comprises the following members:

1. Officers

1a) The Chair and Vice-Chair of the Tourism Services Section of the ITF, who shall be elected at the Tourism Services Section Conference at Congress in accordance with Rules XIII (5) and XIII (8).

- 1b) The Chair and Vice-Chair of the Tourism Services Section of the ITF shall act as Chair and Vice-Chairperson of the Section Committee.

2. Section Conference Representatives

Three representatives to be elected by membership vote of the Tourism Services Section Conference at Congress in accordance with Rule XIII (8) from amongst nominations received at the Tourism Services Section Conference at Congress.

3. Women's Liaison Representative

3a) One Women's Liaison representative to be elected by membership vote of the Tourism Services Section Conference at Congress in accordance with Rule XIII (8) from amongst nominations received at the Tourism Services Section Conference at Congress. Nominations for this post shall be open to women only. The procedure for such elections is as set out below.

- 3b) The Women's Liaison representatives' functions, in addition to full participation and membership of the Section Committee shall be to represent the industrial interests of the Section at meetings of the ITF Women's Committee, and to report on the ITF Women's Committee to the Section Committee. As a consequence, the Women's Liaison Representative shall also be a full member of the ITF Women's Committee.

4. Secretariat Representatives

The Section Secretary and such Secretariat staff as he/she deems fit, who shall be ex-officio members of the Section Committee.

5. Co-option

The Section Committee shall have the power to co-opt additional members or to replace positions that become vacant.

6. Term of Office

The period of office of the Section Committee shall be from the date of the Tourism Services Section Conference at Congress until the next Tourism Services Section Conference at the following Congress.
